

The property is a purpose-built 64-bed residential behavioral health facility currently operated as Recovery Works Elizabethtown. The 21,460 square-feet of rentable space spans 2.91 acres and includes residential patient housing, administrative offices, counseling rooms, dining facilities, shared common areas, and a commercial kitchen. The facility provides inpatient substance use disorder treatment, focusing on residential rehabilitation, and is fully licensed and accredited for substance abuse services. The property layout and infrastructure support continued behavioral health, recovery housing, or similar healthcare use, offering a turnkey environment across the highway from Baptist Health Hardin for an incoming operator.

Additionally, there is a 6,730 SF property on the other side of the road to the south that was used as an intake office. This property is on a different lease that expires in February of 2028 for an annual rent of \$58,080. It is also available for sublease.


## AREA MAP

## LOCATION MAP










## FLOOR PLANS

BUILDING 102 LOWER LEVEL




## FLOOR PLANS


